

## CONSENT FORM

### GENERAL CONSENT, EMERGENCY TREATMENT AND MEDICAL INFORMATION FOR PACT INTERNATIONAL OR EXCHANGE PUPILS

#### GENERAL CONSENT

Pupils in PACT schools undertake a number of educational visits during the year in order to enhance their studies in particular subjects, and visitors are also invited into school for specific curriculum-related workshops. These costs will be included in the school fees (unless otherwise advised).

Pupils may also travel to off-site facilities, venues or other schools for activities such as sports or external competitions. Photographs are taken regularly of pupils while they participate in school activities for the purposes of displays, slideshows, publicity in any of the PACT schools, newsletters and websites. Video recordings may also be made during productions and other activities. Please note that photographs will not be accompanied by any personal details of individual pupils.

Certain personal information is held on file (ie. children's names, year group, host family details, parents contact numbers & email addresses, medical details etc). For the purposes of school administration and to facilitate contact between parties, certain details may be made available as required.

#### EMERGENCY TREATMENT

Many staff at PACT schools have been trained in First Aid procedures, and they are able to attend to most injuries which occur at school. Please refer to the school's website for full details of key policies. However, in the case of a serious accident or incident while in the UK, a member of staff (or the host family) will take the child involved to a local hospital (or by ambulance if required). The host family will contact the parents as soon as possible, keeping in mind that the welfare and safety of the child are the first priority. However, staff and host families require parental permission for your child to be treated in a medical emergency, and this form would be handed to a doctor so that your child can be treated as quickly as possible.

#### MEDICAL INFORMATION

Please provide details on the Consent Form about your child's medical background. This includes any medication currently being taken, allergies, special dietary needs or any other health problems which the school and/or host family need to be aware of (please use a separate sheet if required).

Please note that host families should not bring children into school for at least 24 hours after the last bout of vomiting or diarrhoea. They should also not bring in a child who is looking ill or is not fully recovered from a period of illness. It may also be necessary for host families or the school to administer medicines to their international students, as prescribed by a medical professional.
